

## **SHIRLEY HIGH SCHOOL USAGE** **TERMS AND CONDITIONS**

**BIKES, SCOOTERS, ROLLER SKATES, SKATE BOARDS ARE NOT ALLOWED ON THE COURTS AT ANY TIME.**  
**NO OTHER BALL GAMES ARE ALLOWED WHILST NETBALL IS TAKING PLACE.**  
**NO DOGS ALLOWED AND NO SMOKING ALLOWED ANYWHERE ON THE SCHOOL PREMISES.**

**FAILURE TO ADHERE WITH REGARD TO THE USE OF THE BIKES, SCOOTERS ETC AND THE CORRECT PARKING PROCEDURE MAY RESULT IN THE INDIVIDUALS BECOMING LIABLE AS A CONSEQUENCE OF THEIR ACTIONS AND THE FACILITIES WHICH WE AVAIL OURSELVES OF BEING WITHDRAWN.**

**The HOME named team after the final game on your allocated court must put away both posts back into the netted compound after their game, which would normally be relevant to the 2pm games. In addition, after removing the sunken posts ENSURE you replace the lid/drum.**

**PLEASE ONLY PARK IN THE ALLOTTED BAYS IN THE CAR PARK, IF FULL UNFORTUNATELY YOU WILL NEED TO PARK IN THE ROAD IN A SAFE MANNER. DO NOT PARK IN FRONT OF THE LOCKED EMERGENCY EXIT GATES. CNL PARKING PERMITS ARE AVAILABLE, TO ENSURE SHOULD A PROBLEM OCCUR IN THE CAR PARK IT IS NOT DOWN TO ONE OF US!!**

**The Netball courts and allocated toilets are only to be used. The rest of the school is OUT OF BOUNDS to players and their spectators.**

**Every team will be responsible for their own First Aid Kit and to ensure that there is a mobile phone on site for calling the emergency services as necessary. There are no telephone facilities for CNL use at Shirley High School.**

There is a caretaker on site and should the need arise for the emergency services ONLY to be called, the person doing the refreshments has a number to arrange for the locked gates to be opened.

The toilets will be opened and closed by the caretaker, and must be left in the condition that you would expect to find them in.

**Evening League** – players, umpires, spectators have the responsibility to conduct themselves and act appropriately whilst on court and upon arrival and departure. Must be aware of the residential amenities of the adjoining occupiers must be respected at all times. Excessive noise will not be tolerated and the School and CNL shall reserve the right to eject from the site persons who do not comply. The floodlighting will be the responsibility of the caretaker but clubs/teams have the responsibility of setting up the posts and securely putting them away and replacing the lid/drums.

**Covid 19 Protocols/Guidelines** – players, umpires, spectators must have read and adhere to what is required so that we can start the current season in the best manner and being mindful of everyone around you and the school. This will be required at the end of Part 1 for further consideration.

Please make sure ALL your players are aware of the points above, as it would be a shame to have to speak to anyone on any of the above points. Especially after all the hard work in getting the courts resurfaced to such a great condition and the newly installed floodlighting.
